- I want to be a team member of this Grassroots Trust Mission trip to India. I have chosen to come myself, and am under no obligation or pressure from The Grassroots Trust.
- I understand I must have a **valid UK passport with a valid visa to India for the dates of this trip** and that it is my responsibility to have this with me throughout the mission trip.
- I understand that **travel insurance** is provided by Grassroots for this trip and that I must make a contribution to the trusts Insurance policy. I therefore must declare any preexisting medical condition to the trust. Beyond this insurance, The Grassroots Trust is not responsible in any way for either my health needs or any property I bring with me on the mission trip.
- I understand that there are dangers in travelling to and in India. These include the risk of infectious or water-borne diseases, accident (in or out of means of transport), loss of property, crime and/or terrorist attack. All these risks I **accept as my own responsibility** and will not hold The Grassroots Trust, its directors or trustees responsible in any way.
- I understand that it is my own responsibility to take all normal precautions and get any **vaccinations** that I consider necessary having taken advice from my GP.
- Even though Grassroots will be organising for the team to have some food and drink – often provided by church groups or from cafes – I understand that it is my choice & responsibility whether to eat/drink the food/drink and to follow normal hygiene procedures.
- If I **bring my driving license and drive any vehicle** it is completely my responsibility to make sure I am insured properly, and not the responsibility of Grassroots. I also understand that whether I travel in a vehicle driven by myself or someone else it is my choice and my responsibility to consider whether the vehicle is road worthy, the driver competent and the time/route safe. None of this is the responsibility of the Grassroots Trust or any group leader, whether staff or volunteer.
- I confirm that I have **never been convicted of any offence** in any criminal proceeding in any court, in any country (apart of motoring offences that did not result in disqualification). Please contact us if this is not the case.
- My conduct has **never caused mental or physical harm to a child or young person** or put a child at risk. To my knowledge it has never been alleged that my conduct has resulted in any of those things.
- I understand that there have been **terrorist threats** towards British citizens in holiday areas – as detailed on the UK Foreign Office website. I have made the decision to come in this knowledge and will not hold The Grassroots Trust responsible should the terrorist risk increase and I decide not to come.
